RE-ADVERT: SUPPLY, DELIVERY, AND INSTALLATION OF TWO WALL MOUNTED AIR CONDITIONERS AND RE-GASSING OF FIRE SUPPRESSION IN THE WRDM SERVER ROOM. WR/CORP/12/2025.

1. BACKGROUND

The air conditioners in the server room are not functioning well and the server room requires to be cool all the time, and the fire suppression gas is depleted and requires a re-gas.

2. PURPOSE

The purpose of this submission is to request quotations for two air conditioners and the re-gassing of the fire suppression in the server room. The air conditioners are leaking, which poses a risk of fire and it will be difficult for that fire to be extinguished since the fire suppression gas is depleted.
